

# Terms and Conditions

## MyRepublic Gigatown Competition



1. Information on how to enter and prizes forms part of the Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

2. Entry is limited to Australian residents aged 18 years and over. Employees of the Promoter and their immediate families, and employees of the Promoter's suppliers and associated companies are ineligible to enter this competition.

The Promoter, in its absolute discretion reserves the right to verify the validity of all entries and entrants at any time (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process.
