

MyRepublic MasterCard Virtual e-Gift Card Offer Promotional Terms & Conditions

1. Eligibility

- The MasterCard Virtual e-Gift Card promotional offer ("Offer") is only available in selected areas to new MyRepublic residential customers who signs up online to an eligible MyRepublic nbn™ plan on a 12-month term and entered Promo Code: XMASTREAT during sign up.
- This Offer commences on the 2nd December 2019 00:01AM AEDT and ends 19th December 2019 11:59PM AEDT ("Offer Period").
- To be eligible, new customers must be in an nbn™ serviceable area and passes MyRepublic's service qualification and application process. The connection may be activated after this date.

2. Eligible Plans & Offer Details

- The MasterCard Virtual e-Gift Card is supplied by Corporate Prepaid Cards Pty Ltd ("Distributor") ACN 092 828 772 of PO BOX 117, Balmain, NSW, 2041 Australia and is use of the MasterCard Virtual e-Gift Card is subject to their terms and conditions set out in <https://giftcardstore.com.au/terms/> ("CPC Terms").
- The MasterCard Virtual e-Gift Card will be sent via email to the email address used during the MyRepublic sign process and sent within 7 business days of your order being accepted by MyRepublic. MyRepublic or the Distributor is not responsible for any undelivered emails due to your SPAM filters or email settings.
- You must activate your MasterCard Virtual e-Gift Card by the date stipulated in the email (3-months) you receive with your MasterCard Virtual e-Gift Card prior to use. If you do not activate your card by the date indicated on your email and in accordance to the CPC Terms, it will be canceled and the balance forfeited.

- If you require a MasterCard Virtual e-Gift Card to be replaced this will incur a \$10 one off charge.
- The MasterCard Virtual e-Gift Card is a single-load card and cannot be topped up or reloaded.
- The MasterCard Virtual e-Gift Card can only be used online on websites that accepts MasterCard; subject to restrictions such as, but not limited to, in-store purchases, ATM machine, gambling and by merchants for card-not-present transactions.
- If your card is used for purchases in any currency other than Australian dollars or with any merchant located outside Australia, a foreign exchange fee applies.
- The MasterCard Virtual e-Gift Card pre-loaded value will expire as per the expiry date shared in the email (12-months) and any remaining balance will be forfeited. You can check the balance of your card at: <https://universalgiftcard.com.au/> or contacting Corporate Prepaid Cards on 1800 174 239.
- The MasterCard Virtual e-Gift Card cannot be used for cash advances, redeemed for cash, reloaded or returned for a refund.
- You may make a purchase exceeding the \$ value on the card if the retailer accepts split transactions. However this is generally not available with online retailers.
- Any disputes about goods or services purchased with the MasterCard Virtual e-Gift Card must be resolved with the retailer directly.
- MyRepublic or the Distributor is not responsible for any misuse, lost, stolen or damaged accounts. You are responsible for all transactions made on the Virtual e-Gift Card, except where there has been fraud or negligence by MyRepublic or the Distributor's staff or agents. If you notice any errors relating to your account, you should notify Corporate Prepaid Cards Pty Ltd immediately.
- There is no limit on the amount of transactions available on this card as long as the available balance is not exceeded and the card has not expired.

4. Other Terms

- If you terminate your Eligible Plan before the end of your 12-month minimum service term, an Early Termination Fee of up to \$240.00 will apply.
- If you cancel your order for your eligible MyRepublic nbn™ 12 month contract plan prior to your service being activated and have received a MasterCard Virtual e-Gift Card, MyRepublic reserves the right to cancel your MasterCard Virtual e-Gift Card without prior notice.
- This Offer can be extended or withdrawn by MyRepublic at any time.
- This Offer cannot be used in conjunction with any other discount or promotional offer.
